# Universal Declaration of Yahweh's Law: (Kingdom of Arzareth) - House of Israel and House of Judah);

**Expressed hereby under Claim of Right:** 

## THE NEW COVENANT WITH ISRAEL AND JUDAH

( JEREMIAH 31:31-37 )

31Behold, the days come, saith the LORD, that I will make a new covenant with the house of Israel, and with the house of Judah: 32not according to the covenant that I made with their fathers in the day that I took them by the hand to bring them out of the land of Egypt; which my covenant they brake, although I was an husband unto them, saith the LORD: 33but this shall be the covenant that I will make with the house of Israel; After those days, saith the LORD, I will put my law in their inward parts, and write it in their hearts; and will be their God, and they shall be my people. 34And they shall teach no more every man his neighbor, and every man his brother, saying, Know the LORD: for they shall all know me, from the least of them unto the greatest of them, saith the LORD: for I will forgive their iniquity, and I will remember their sin no more.35 Thus saith the LORD, which giveth the sun for a light by day, and the ordinances of the moon and of the stars for a light by night, which divideth the sea when the waves thereof roar; The LORD of hosts is his name: 36 If those ordinances depart from before me, saith the LORD, then the seed of Israel also shall cease from being a nation before me for ever. 37 Thus saith the LORD; If heaven above can be measured, and the foundations of the earth searched out beneath, I will also cast off all the seed of Israel for all that they have done, saith the LORD.

## **Preamble:**

Recognizing and agreeing that; "All acts of the legislature apparently contrary to natural rights and justice are, in our law and must be in the nature of things, considered as void. The laws of nature are the laws of God [Yahweh, the Creator], whose authority can't be superseded by no power on earth. A legislature must not obstruct our obedience to Him from whose punishments they cannot protect us. All human constitutions which contradict His laws (God's [Yahweh, the Creator's]), we are in conscience bound to disobey." (1772, Robin v. Hardaway, 1 Jefferson 109.); and

Knowing that we are peaceful man and woman, who may be referred to by that name which is called: Kingdom of Arzareth, and that we are expanding this reach of discourse in good conscience and according to our inherent free will to express ourselves, and in order to maintain Yahweh's honor and ensure maximum clarity between us (Kingdom of Arzareth) and all agents of domestic governments and international governing bodies, concerning our peaceful life as well as our desire to avoid all conflict, and to live lawfully and peacefully on and within the geographical land mass commonly known as the country of the United States of America and Canada (the Americas), and elsewhere from time to time as the case may be; and

Having lawful capacity as Yahweh's people of adequate age to comprehend the difference between our Creators given fundamental natural rights and freedoms, being those rights and freedoms that are intrinsic to our being and are inalienable, and that we are born with and enjoy by the fact of being alive, and that are neither created nor can be abrogated in whole or in part by any government or by any other individual, as distinct from those "human rights" and "legal rights" as otherwise defined and fabricated by men, and knowing that it is irrefutable that a right is not a compulsion;

And realizing that it is our duty and obligation to freely choose, and to eliminate all ambiguity by removing any presumption and assumption and potential for confusion, therefore it is our further duty and obligation to declare and to make known by this instrument, our choice as to whether or not to exercise all or any of the optional *human rights* or *legal rights* as defined and set forth in,

but not limited to the following instruments, declarations, charters, treaties, covenants, bills or other acts of governments and men and women, which although not directly appended hereto, shall each be considered incorporated herein by reference in their respective entirety:

Having the further capacity to comprehend that *legal rights* and *human rights* entail both rights and obligations, We hold an excellent appreciation for the \*United Nations Human Rights Council, which currently enjoys a mandate to monitor and enforce the obligations of its member States to protect and fulfill *human rights* for everyone, everywhere; and (\*See "Appendix A", entitled "SC-6.5 - Human Rights Enforcement:", attached hereto and incorporated herein by reference in its entirety.)

Knowing that our Creator [Yahweh, the one true God] has blessed us with his own family according to His will, it is therefore my natural duty and obligation to accept all responsibilities to provide for our own family, to protect our own family, and to honor the inherent natural rights and needs of our own family, and to make just claim to any rights for each member of our own family, whether natural rights, human rights, or legal rights on their respective behalf, at our sole unfettered discretion and according to our and God's will; and

Knowing that we are to be considered and respected by everyone as being equal in all ways to all men and women everywhere, and as having been born on this earth and as having been created to enjoy my fundamental natural rights and freedoms together with our free and unfettered share of the dominion over the earth equally with all men and woman everywhere; and

Knowing also that it is both our duty and our obligation to accept and to cherish with a clear conscience that inheritance which our Creator has blessed us with, particularly our free will to express ourselves together with the naturally inherent knowledge of what is right and what is wrong behavior between men and woman, we are bound therefore to express our intention to

respect the natural rights and freedoms of all people, to do no harm to any others, and to respect their choices made and expressed, and to honor our Creator by accepting His most gracious blessings as our just inheritance with all thanksgiving; and

Knowing also that our well pleased that the administrative body of men and women operating as the government of the country and nation commonly referred to as United States of America and Canada, declares itself to be "founded upon principles that recognize the supremacy of God and the rule of law":

**NOW THEREFORE,** in this instrument, the words "our", "people", "men", "women", "ourselves" "own", and "his" "us" "we", and all declarations and claims and other petitions made herein in association with any of the words "our", "people", "men", "women", "ourselves" "own" "us" "we", and "his" shall be deemed to apply equally and severally to each of persons of the Kingdom of Arzareth, who may be referred to by that name which is called, : children of God, or the name they chose or God chooses for them who may be referred to by that name, as living members of Yahweh's family dwelling peacefully under his protection and authority, as if each of them had made this instrument as their own declaration of their own private law under claim of right;

**AND NOW THEREFORE** being that it is our duty and responsibility to express our free will and to make our free will known to all men and women everywhere, We do make this instrument as a record of our Declaration under our Claim of Right on behalf of ourselves and on behalf of each member of his/her family, to establish and secure our God given laws regarding our Creator given fundamental natural rights, our claimed *legal rights* and our claimed *human rights* insofar as these may apply to us and to each member of our own family; and (\*\*see "UNDRR"; and "Appendix B", entitled "T5- Private Law:" attached hereto and incorporated herein by reference in its entirety.)

- i) We claim our rights at all times to exercise all of our Creator given natural rights and freedoms that are intrinsic to our being and inalienable, that we are born with and that we enjoy by the fact of being alive, and that are neither created by men nor governments, nor can they be abrogated by any government or by any other individual without our informed and voluntary consent; and (see authorized King James Bible, which is incorporated herein by reference in its entirety.)
- **ii)** We claim our \*\*\*liberty at all times in the form of all of our Creator given fundamental natural rights and freedoms, some of which are recognized in the "USAR" "UDHR", and some of which are recognized in the "IBHR", and some of which are recognized in various other domestic and international instruments, declarations, charters, treaties, covenants, bills or other *legal acts* of governments and men; and (\*\*\*see "Appendix C", entitled "**P- Definition of Liberty:**" attached hereto and incorporated herein by reference in its entirety.)
- **iii)** We claim our natural and human right at all times hereafter to waive and to not exercise our **"right to recognition everywhere as a person before the law" \*\*\*\***Article 6, "UDHR", and \*\*\*\*\*Article 16, ICCPR, and to exercise my right not to be compelled to have a *legal* name or to be enjoined with a *legal* name \*\*\*\*Article 24, sub-clause 2: "ICCPR", and instead invoke our right to be recognized and treated everywhere as a competent man or woman of capacity born of God's creation (*a living human being*); and

**iv)** We claim our natural and *human* right at all times hereafter to waive and to not exercise any *legal rights* or any *human rights* that would in any way abrogate in whole or in part, any of our Creator given fundamental natural rights and freedoms or any of our remaining claimed or available *human rights*, and we further claim our right to be excluded from any possibility of

being *legally* presumed and or *legally* manipulated (whether by tacit consent or by *de facto* default, or by any other *legal* means) into exercising any *legal* rights or any human rights that would in any way abrogate in whole or in part, any of our Creator given fundamental natural rights and freedoms or any of our remaining claimed or available *human* rights, without our informed and voluntary consent; and

- **v)** Excepting as otherwise expressly provided for herein, We claim our natural right at all times to exercise any *legal rights* and any *human rights* inclusive but not limited to those rights set forth in the USAC UDHR, the ICCPR, the IBHR, the CAC, the CBR, the CCRF, the ICESCR, and in the *maxims of the common law* as held in the Commonwealth nations, and in the *Claim of Right Act*, and in the *Coronation Oath*, and in the *ancient charters and statutes confirming the liberties of the Commonwealth subjects*, that by so exercising, would not in any way abrogate in whole or in part, any of our Creator given fundamental natural rights and freedoms, or any of our remaining claimed or available *human rights*; and
- **vi)** We claim our natural right at all times to the gifts and to the blessings of our Creator, as He has bequeathed to us a shared dominion over the earth and all things of it, which is our inheritance and our birthright, given to us by our Creator who is God, according to His free will; and (see KJV Bible Genesis 1:26)
- **vii)** We claim our natural and *human* right at all times to our \*\*\*\*\*Patrimony, being our lawful and *legal* Entitlement to the free and unfettered possession of an identifiable and quantifiable share of the natural wealth and resources of the geographical land mass commonly known as the country of United States of America and Canada, or in the alternative, to receive in a timely and satisfactory manner adequate and appropriate compensation for such a share of the natural wealth and resources of the geographical land mass commonly known as the country of United States of America and Canada; and

(\*\*\*\*\*see "Appendix E", entitled "General Assembly resolution 1803 (XVII) of 14 December 1962, Permanent sovereignty over natural resources", attached hereto and incorporated herein by reference in its entirety; and see "Appendix F", entitled "T-Patrimony", also attached hereto and incorporated herein by reference in its entirety.)

- **viii)** We claim our natural and *human* right to freedom and liberty from servitude and slavery at all times while living on and within the geographical land mass commonly known as the country of United States of America and Canada or elsewhere from time to time as the case may be, inasmuch as we do not consent to be recognized as, or treated as, or to be *legally* enjoined with, or to be any form of surety for the United States of America and Canada (*or Canada province*) created *legal person* with a name-title similar to that which is used for our own name-calling, whether or not that *person* is a fiction, artificial, juridical or other form of *legal person*;
- a) and in furtherance thereof, We claim our right that the governments of the United States of America and provinces and territories of Canada and the Canada government and their respective subordinate agents as the case may be, shall at all times hereafter unconditionally and irrevocably guarantee to indemnify us and save us harmless of any financial, monetary or commercial debts, obligations, fees, costs, charges, fealty, securities or undertakings or *legal* obligations of any kind associated directly or indirectly with the said United States of America and Canada (*or Canada province*) created *legal person*;
- b) and in furtherance thereof, We claim the unfettered right to refuse any *legal* joiner with the *legal* entity/artificial *person*, as we are not the creator or the originator of that entity, and it cannot be inferred or implied that we have accepted *legal* joiner with the *person* through any act or omission of any act on our part, without our informed and voluntary consent; and
- c) and in furtherance thereof, We claim our right to hereby immediately and permanently rescind, cancel, withdraw and terminate for cause of fraud and wilful non-disclosure any existing actual and implied *legal* authorizations, contracts, agreements, and other obligations of any kind associated directly or indirectly with the said United States of America and Canada (*or Canada*)

province) created *legal person*, whether made written, or oral, or otherwise, and whether made by anyone, by or on behalf of the United States of America and Canada (or Canada province) created *legal person* with a name-title similar to our own name-calling, or whether made unwittingly by us prior actions or by omissions of actions by us or by my signature(s) on its behalf; and

- d) and in furtherance thereof, We make this my claim to any available rights, together with our right to waive and to not exercise any *legal rights* or any *human rights*, together with our right to be excluded from any possibility of being *legally* presumed and or *legally* manipulated (whether by tacit consent or by *de facto* default, or by any other *legal* means) into exercising any *legal rights* or any *human rights* that would in any way abrogate in whole or in part, any of our Creator given fundamental natural rights and freedoms or any of our remaining claimed or available *human rights*, to extend and to apply to and on behalf of each member of our own family pursuant to, but not limited to the provisions of the ICCPR, **Article 23**, **sub-clauses 1,2,3** & **4**; and **Article 24**, **sub-clauses 1,2,& 3**.; and
- e) and in furtherance thereof, We claim our natural and human right to self-determination inclusive of our right to freely determine our political status and our nationality and for sake of clarity and elimination of all ambiguity and uncertainty, We are a living man and women of the Creator God, and also known as a human beings living on our Creator God's earth, and our nationality is with the creator God's kingdom, and our citizenship is of our Creator God which He has promised is registered for me in Heaven, and I am politically affiliated only with our Creator God, and we are bound by the naturally supreme laws of our Creator God, and according to His good and perfect will we are a temporal sojourner on His earth, and as such, it is our sincere intention according to the record of our Creator God's will for us, to be obedient to the fabricated laws of men and governments of men, but only insofar as those fabricated laws are found to be in perfect harmony with my Creator God's supreme laws; and (see ICCPR, PART I, Article 1; and Article 24; and UDHR, Article 15. (1) and (2).)
- **ix)** We claim our natural and *human* right at all times while living on and within the geographical land mass commonly known as the country of United States of America and Canada, to have the governments of the states, city's, towns, provinces and territories of United States of America and Canada and the United States of America and Canada government and their respective subordinate agents as the case may be:
- a) to assume and satisfy their obligations and duties under domestic and international law to respect, to protect and to enable fulfillment of our natural rights and any claimed or available *human rights* at all times according to our will; and
- b) to assume and satisfy their obligations to refrain from interfering with or from curtailing our enjoyment of our natural rights and any claimed or available *human rights* at all times according to our will; and
- c) to assume and satisfy their obligations to protect us against abuses of our natural rights and against *human rights* abuses; and
- d) to assume and satisfy their obligations to take positive action to facilitate our enjoyment of our natural rights and any claimed or available *human rights* at all times according to our will; and
- e) to assume and satisfy their obligations to take positive action to ensure I receive the full benefit and enjoyment of our Patrimony and all other entitlements according to our needs in a timely manner and according to our will; and
- **x)** We claim our *human* rights at all times while living on and within the geographical land mass commonly known as the country of United States of America and Canada or elsewhere from time to time as the case may be, to report offenses against any of our claimed or available *human*

*rights* directly to the United States Government and Office of the High Commissioner for Human Rights ("OHCHR"), and to make demand directly to OHCHR:

- a) for expertise and support from the different *human rights* monitoring mechanisms within the United Nations system; and
- b) for expertise and support from the different United Nations Charter-based bodies, including the Human Rights Council, and other bodies created under the international *human rights* treaties and made up of independent experts mandated to monitor member State parties' compliance with their treaty obligations; and
- c) for protection of our *human rights* at all times according to our will, and for enforcement of the member State's obligations related to our claimed *human rights* at all times; and
- **xi)** Having enjoyed our rights to freely express this, our universal declaration of our private law on behalf of the Kingdom of Arzareth and on behalf of each member of our own family, We claim our lawful and *legal* rights to publish this instrument by posting true copies of it on our private property and in appropriate public places and by making registered postal delivery of true copies of it, to the parties listed below as "Recipients", with the *legal* recognition that the law of agent and principal applies wherein registered delivery to any of the principals constitutes *legal* notice to their respective agents by association, and registered delivery to any of the agents constitutes *legal* notice to their respective principals by association, and that such registered delivery and notice constitutes sufficient and fully satisfied service of all of the parties, express or implied, without recourse and without requirement of further notice of any kind to or from any party:
